WHEREAS Northbridge proposed to adopt the IAO rating program for Miscellaneous Vehicles
 accepted for use by the Board in information bulletin A.I. 2024-04; and

- 28 WHEREAS Northbridge also proposed the following changes:
 - adopt the 2024 CLEAR rate group table for Motorcycles;
- 30 rating rule adjustments;
 - surcharge adjustments; and
 - changes to endorsement pricing; and

- WHEREAS the proposed rating program results in overall rate level changes of -11.6%, -13.5%,
 -17.8% and -17.8% for Motorcycles, ATVs, Motorized Snow Vehicles and Motorhomes,
 respectively; and
