

PETROLEUM PRODUCTS PRICING REVIEW HIGHLIGHTS FOR LABRADOR CONSUMERS AND INDUSTRY

BOARD REQUESTS ADDITIONAL INFORMATION AND COMMENTARY

The Board is seeking additional information and commentary from consumers and industry in Labrador as part of its ongoing review of petroleum products pricing regulation in the province. A significant amount of information has been gathered and analyzed by the Board and its consultants throughout this review and a number of potential changes have been identified. The Board is now inviting consumers and industry in Labrador to provide their views and further information on these potential changes before the Board makes its determinations.

POTENTIAL CHANGES BEING CONSIDERED FOR LABRADOR

The potential changes being considered by the Board would, if implemented, impact maximum prices in Labrador as well as the processes used by the Board for establishing these prices.

- Potential Increases in Maximum Prices in Labrador-

Based on the information gathered to date retail supply costs have increased in recent years. If it is determined that these cost changes should be reflected in the retail mark-ups, maximum prices for regulated petroleum products in Labrador may increase. It is estimated that maximum prices could increase by 2.58 cents per litre for regular gasoline, 2.72 cents per litre for diesel motor fuel and 2.46 cents per litre for stove oil heating fuel in most Labrador zones.

Wholesaler supply costs in Labrador were assessed by the Board as part of the Interim Labrador Review and changes were made to the zone differentials to reflect wholesaler cost increases. While wholesalers have suggested costs have increased since the Interim Labrador Review, the information provided thus far does not support additional changes to the wholesale mark-ups or zone differentials at this time. The Board is considering changes to make the mark-ups consistent throughout the Province.

The estimated impacts of potential mark-up and zone differential changes for all areas of Labrador are set out in the attached table.



- Potential Changes to Zoning in Marine Tanker Supplied Areas -

Based on recent information indicating changes to storage and supply dynamics in the marine tanker supplied areas, the Board:

- may combine Black Tickle (Zone 11a), William's Harbour and Norman's Bay (Zone 11b); and
- will determine whether a new pricing zone should be created for the Town of Cartwright.

- Other Potential Changes for Labrador -

Other matters the Board is considering for Labrador include:

- Changes to the blending methodology for diesel motor fuel in Western Labrador.
- Changes to the calculation of benchmark prices to reflect a new data reporting agency and an average of five days of data for Western Labrador, similar to that proposed for the Island.
- A shift in weekly price adjustments from Thursday to Friday for Western Labrador, similar to that proposed for the Island.
- More regular reviews of wholesale and retail mark-ups and zone differentials.
- A recommendation that Government:
 - o consider changes to the Regulations for better cost recovery for higher grades of gasoline motor fuel in Western Labrador, similar to that proposed for the Island.
 - o consider changes to the Regulations to provide more discretion for the Board to better reflect product costs in maximum prices in Western Labrador, similar to the rest of Labrador.
