**Weekly Adjustment of Maximum Prices of Regulated Petroleum Products
Implementation of Petroleum Products Pricing Review Changes on the Island**

Maximum Price Adjustments

Effective 12:01 a.m. Thursday, March 13, 2025, the Public Utilities Board set maximum prices for regulated petroleum products in all areas of the province, except where maximum price adjustments have been suspended.

For the Island portion of the Province, the maximum price adjustments this week reflect:

- (i) changes in market commodity prices; and
- (ii) the implementation of changes on the Island portion of the Province resulting from the Petroleum Products Pricing Review (the “Review”).

The changes to maximum fuel prices on the Island are as follows:

- all types of gasoline motor fuel will decrease in a range of 3.7 cents per litre (“cpl”) to 4.8 cpl;
- diesel motor fuel will decrease in a range of 3.5 cpl to 4.7 cpl;
- furnace oil heating fuel will decrease in a range of 3.10 cpl to 4.10 cpl; and,
- propane heating fuel will decrease by 1.4 cpl.

A detailed breakdown of the changes to maximum prices on the Island, by product by pricing zone, is set out in the attached tables.

For Labrador, the maximum price adjustments this week reflect changes in commodity market prices only as the Board has not yet completed its review for Labrador. The changes to maximum prices in Labrador are as follows:

- all types of gasoline motor fuel in Zones 13 and 13a will decrease by 4.8 cpl;
- diesel motor fuel in Zones 13 and 13a will decrease by 4.7 cpl;
- stove oil heating fuel in Zones 13 and 13a will decrease by 3.85 cpl; and
- propane heating fuel in all Labrador zones will decrease by 1.4 cpl.

While the Board's next regularly scheduled price adjustment is on Friday, March 21, 2025, the Board continues to monitor changes in market prices for motor fuels and heating fuels and will adjust maximum prices outside the scheduled adjustment as appropriate.

Implementation of Petroleum Products Pricing Review Changes on the Island

The Review was conducted by the Board in accordance with the direction of the Minister of Digital Government and Service NL, pursuant to Section 8.1(3) of the **Petroleum Products Act**. Based on the information and feedback provided during the Review, the following changes for the Island portion of the Province are effective with this week's price adjustment:

- zone differential increases for gasoline and diesel motor fuels and furnace oil heating fuel as set out in **Order No. P.P. 16(2025)**.

These changes are discussed in detail in the Board's **Final Report - Island**. For more information, please see the Board's **Highlights Document**.

As set out in the attached Schedule of Dates effective next week the Board will complete the implementation of the changes to petroleum products pricing on the Island flowing from the Review, including a transition to Friday maximum price adjustments and the use of Argus Media-reported market data in the calculation of average benchmark prices.
