18	WHEREAS in Order No. P.U. 30(2019) the Board approved, among other things, Policies for
19	Automatic Rate Changes so that as Newfoundland Power Inc. ("Newfoundland Power") changes
20	its rates Hydro will automatically adjust certain rates for its customers on the Island
21	Interconnected system and the L'Anse au Loup system and its Isolated Rural customers; and
22	NAMEDEAG in Order in Council OC3024 003 Courses and continued its discretion that showers in
23	WHEREAS in Order in Council OC2024-092 Government continued its direction that changes in
24	rates for Non-Government Rural Isolated Domestic and General Service customers of Hydro shall
25	be equal to changes approved for equivalent rate classes of Newfoundland Power; and

 Schedule of Rates, Tolls and Charges for Newfoundland Power to be effective August 1, 2024; and
