**Re: Newfoundland and Labrador Hydro – 2017 General Rate Application
Board's Request for Further Information**

In relation to the general rate application filed by Hydro on July 28, 2017 the Board requires that Hydro provide the following:

1. Hydro's proposals with respect to final rates for 2018.
2. The estimated impact on rates of the conclusion of the RSP rate mitigation adjustment, maintaining all other assumptions in the application constant and setting out any proposals with respect to this adjustment and/or the July 1, 2018 RSP adjustment generally.
3. Hydro's proposals for the recovery of the balances in the Isolated Systems Supply Cost Variance Deferral Account, the Energy Supply Cost Variance Deferral Account and the Holyrood Conversion Rate Deferral Account, and the estimated impact of the recovery of these balances on the proposed 2018 and 2019 rates.
4. The date when the supplemental evidence in relation to the Off-Island Purchases Deferral Account will be filed (page 1.5 of the application).

This information should be filed by Friday, August 25, 2017.
