Re: Rate Mitigation Options and Impacts Reference - Revisions to Responses to Information Requests

We are writing to request updates to the responses that Nalcor has previously provided to Information Requests PUB-Nalcor-027, 028, 029 and 078 to reflect recent changes to the domestic customer rates on the Island Interconnected System as of October 1, 2019, and the availability of more recent forecast financial information.

PUB-Nalcor-027 should be revised to reflect the most current domestic rate as of October 1, 2019, and any changes in rates paid by domestic customers in each Atlantic Province including revised 2021 forecast rates since the response was provided.

PUB-Nalcor-028 should be revised to reflect the most current domestic rate as of October 1, 2019, and the most recent rates paid by domestic customers in each Province.

PUB-Nalcor-029 should be revised to reflect the current domestic rate as of October 1, 2019, and the current forecast of domestic electricity rates for the period 2020-2039.

PUB-Nalcor-078 should be revised to reflect the change in the 2021 forecast average domestic rate as per the revisions to PUB-Nalcor-027 and 029, and an explanation of how this rate relates to the forecast of 22.89 cents/kWh for 2021 provided in the Reference Questions issued by the Government of Newfoundland and Labrador and by Nalcor in the response to PUB-Nalcor-026. In the response confirm what is the current forecast for the 2021 average unmitigated domestic electricity rate and provide a reconciliation explaining all differences between the forecast of 22.89 cents/kwh given in September 2018 in the Reference Questions and in the June 2017 Project Update provided in the response to PUB-Nalcor-026.
