

- As of 2059 hours, July 13, 2023, Stephenville Gas Turbine unavailable due to forced outage (50 MW).
- As of 1011 hours, April 12, 2024, Holyrood Unit 1 unavailable due to planned outage (170 MW).
- C As of 0700 hours, May 26, 2024, Holyrood Unit 3 unavailable due to planned outage (150 MW).
- As of 1856 hours, July 04, 2024, Bay d'Espoir Unit 6 unavailable due to planned outage (76.5 MW).
- As of 0652 hours, July 31, 2024, Labrador Island Link unavailable due to planned outage (700 MW).
- As of 1047 hours, August 02, 2024, Paradise River Unit unavailable due to forced outage (8 MW).

otes: 1. Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact customer supply. Hydro schedules outages to system equipment whenever possible to coincide with periods when customer demands are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.

- 3. Gross continuous unit output.
- 4. Gross output from all Island sources (including Note 4).
- 5. NLH Island Power Purchases include: ML Imports, Exploits Generation, Rattle Brook, Star Lake, Wind Generation and capacity assistance (when applicable).

- 7. Due to limitations inherent in the design of combustion turbines, the output of combustion turbines may be reduced in the event that ambient temperatures exceed the threshold required for full rated output. This threshold is dependent on the design of each turbine.

- 9. LIL Import sunk in the Island System. Actual LIL flows will be restricted by various system conditions including, but not limited to, Island Load, ML Exports and Avalon Unit status.
