Re: The Board's Investigation and Hearing into Supply Issues and Power Outages on the Island Interconnected System- Phase One – Reporting

The Board acknowledges receipt of your correspondence dated January 15, 2015 and January 16, 2015 and the enclosed reports for December 2014 on Generation Availability Additional Reporting, the Integrated Action Plan and Capital Program Status. The Board confirms that at this time it does not require monthly reports on these items for 2015. We also confirm that a report from Hydro on critical spares by February 15, 2015 is required.

The Board has determined that additional information and regular reporting on certain matters is required at this time. Hydro is directed to file monthly updates, as recommended in recommendation 2.1 in Liberty's December 17, 2014 Report, on Hydro's experience with its short term forecast in the previous month, including a description of the forecast for that month from Nostradamus, any adjustments made to the Nostradamus forecast in the month for unusual weather outside the model's ability and industrial load or any other adjustment made to the Nostradamus forecast and an explanation of the variances between the forecast for the month and the actual forecast. The first report should include data for the month of December 2014, and should be filed by January 30, 2015. Subsequent reports are to be filed by the 15th of each month and should include data on the experience in the previous month.
