**Re: Newfoundland and Labrador Hydro - 2026 General Rate Application - To NLH – Outstanding Responses to Requests for Information - Filing Schedule**

The schedule for Newfoundland and Labrador Hydro's 2026 General Rate Application ("GRA"), which was agreed to by parties at the pre-hearing conference, set August 26, 2026 as the filing date for responses to the first round of requests for information ("RFIs"). On August 25, 2026 the Board granted Hydro's request for a brief extension for a subset of responses to the RFIs to be filed on August 31, 2026.

The responses to CA-NLH-083, PUB-NLH-008, PUB-NLH-068 and PUB-NLH-069 remain outstanding. Hydro has advised that work is ongoing to complete the five-year financial model required for these responses, but has not provided a revised filing timeframe.

The responses to these RFIs are now two weeks overdue. The Board notes that there is a short period of time for second round RFIs to be filed and is concerned that the delay in filing these responses could impact the remaining GRA schedule.

The Board requests that Hydro file the outstanding responses by Monday, September 14, 2026.
