 - a) Attachment A provides monthly generation from each of Newfoundland Power's hydro plants from July 2022 to July 2024. Newfoundland Power is unable to provide spill as the Company does not actively track spill from its watersheds.
 - b) Newfoundland Power normally operates its hydroelectric plants in a water management mode where the plant operates to maximize efficient production of electricity given the water conditions at the intake. Newfoundland Power is frequently called upon by Newfoundland and Labrador Hydro to increase production from both Avalon and all-Island hydroelectric plants. Responsibility for dispatching the Company's generation assets ultimately lies with Newfoundland Power's System Control Centre, although decisions are made in consultation with plant operating guidelines, operating procedures, and the relevant supervisors and managers.
 - c) Newfoundland Power's Topsail hydro plant is currently unavailable as the company is responding to an in-service failure in the plant. The plant is expected to return to service prior to the end of 2024.²
