- Q. (Reference Application) In reference to the allowance for "unforeseen items", please provide a history of this allowance from 2000 to the present, and where and when the allowance was called upon, and for what reasons, and what was left in the allowance for unforeseen items at the end of each particular year.
 - A. Newfoundland Power notes that this Request for Information is identical to CA-NP-145 filed in relation to the Company's *2024 Capital Budget Application*.

The annual approved budget amounts, actual cost and remaining budget at year end for the *Allowance for Unforeseen Items* are provided in Attachment A for 2000 to 2023. For 2024, the Company has an approved budget of \$750,000. As of August 23, 2024, the Company has not availed of the 2024 *Allowance for Unforeseen Items*.

Table 1 provides a summary of the events that required use of the *Allowance for Unforeseen Items* from 2000 to 2023.
