Fred Saunders Commissioner **WHEREAS** on June 7th, 2002 the Board of Commissioners of Public Utilities (the "Board") issued Order No. P.U. 7 (2002-2003) in relation to the above matter which ordered, *inter alia*, NLH to pay the expenses of the Board and the Consumer Advocate and further ordered NLH to pay the costs of the Industrial Customers in an amount to be determined by the Board; and

WHEREAS NLH filed an Application with the Board on June 27th, 2002 seeking an order approving the inclusion in the 2002 revenue requirement to be used in setting rates under Order No. P.U. 7 (2002-2003) of the expenses of the Board and the Consumer Advocate in excess of \$1 million and the costs of the Industrial Customers; and

WHEREAS on July 4th 2002 the Board issued Order No. P.U. 10 (2002-2003) which fixed the costs of the Industrial Customers at \$250,000; and

WHEREAS the expenses of the Board and the Consumer Advocate are \$1,554,497.61, plus HST of \$233,174.65, which amount has been billed to NLH; and

WHEREAS the parties to the hearing were provided the opportunity to make submissions on the Application of NLH to include these costs in the 2002 revenue requirement to be recovered through rates; and

WHEREAS on July 8^h , 2002 the Consumer Advocate filed a submission with the Board, and on July 11^{th} , 2002 Newfoundland Power Inc. filed a submission with the Board; and

WHEREAS on July 9th, 2002 NLH filed further information with the Board setting out the amount of \$1,037,072.26, including HST, which it was seeking to recover through rates to be charged to its customers over the period September 1, 2002 to December 31, 2003; and

WHEREAS the Board has considered the information before it and finds that the recovery through rates of the expenses, excluding HST, of the Board and the Consumer Advocate in excess of \$1 million, and the costs of the Industrial Customers as fixed by the Board is reasonable and should be allowed.

IT IS THEREFORE ORDERED THAT

NLH's 2002 revenue requirement shall be adjusted to allow NLH to recover the amount of \$804,498 through rates over the period from September 1, 2002 to December 31, 2003.
